Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below.

- Pre-bid meeting shall be held at Birgunj Metropolitan City, Birgunj, Parsa at 13:00 hours on 2077/06/23 (9th October 2020).
- Electronic bids must be submitted to the office Birgunj Metropolitan City, Birgunj, Parsa through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 hours on 2077/07/04 (20th October 2020). Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on 2077/07/04 (20th October 2020) at the office of Birgunj Metropolitan City, Birgunj, Parsa. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a scanned copy of the bid security in pdf format amounting to a minimum of as shown in table below, which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
