**15-Days Public Notice for Submission of Expression of Interest (EOI) for Collection, Management and Operation of Hospital Waste Management Center (Central Treatment Facility) under Public-Private Partnership (PPP) Concept**

This public notice is hereby issued to invite **Expressions of Interest (EOI)** from eligible private sector entities for the **Collection, Management and Operation of Hospital Waste Management Center (Central Treatment Facility) Public-Private Partnership (PPP) Concept**, for a period of **five (5) years**. The selection of the Consulting Services Partner shall be carried out through a **competitive process** in accordance with the provisions of the **Public Procurement Act, 2063** (Clauses 29, 30, and 31), **Public Procurement Regulation, 2064** (Clauses 14, 70, and 71), **Birgunj Metropolitan City Public Procurement Regulations, 2081** (Clauses 79, 82, and 83), and other prevailing laws, rules, and regulations. EOI's received by this office shall be evaluated, and a **shortlist of qualified applicants** will be prepared. The shortlisted applicants shall subsequently be invited to submit their **Technical and Financial Proposals** through a **Request for Proposal (RFP)** process. Interested and eligible private sector entities are required to submit their EOI **electronically through the National e-GP system ([www.bolpatra.gov.np](http://www.bolpatra.gov.np))** along with the details and supporting documents as specified below.

**Details:**

1. Birgunj Metropolitan City has allocated revenue fund towards the cost of **Collection, Management and Operation of Hospital Waste Management Center (Central Treatment Facility) under Public-Private Partnership (PPP) Concept** and intends to apply a portion of this fund to eligible payments under the Contract for which this Expression of Interest is invited for National consulting service.
2. The Birgunj Metropolitan City now invites Expression of Interest (EOI) from eligible consulting firms ("consultant") to provide the following consulting services: **Collection, Management and Operation of Hospital Waste Management Center (Central Treatment Facility) under Public-Private Partnership (PPP) Concept**. Interested eligible consultants may obtain further information and EOI document fee as mentioned below of cost at the address Birgunj Metropolitan City, Office of the Municipal Executive, Birgunj, on or before 2082/10/02(16<sup>th</sup> January 2026) till 12:00 hours or visit e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) or visit the client's website [www.birgunjmun.gov.np](http://www.birgunjmun.gov.np)
3. Consultants may associate with other consultants to enhance their qualifications.
4. Expressions of interest shall be delivered online through e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **2082/10/02(16<sup>th</sup> January 2026) till 12:00 hours**.
5. Expressions of interest shall be opened online through e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 2082/10/02(16<sup>th</sup> January 2026) at 13:00 hours in the department of Procurement Unit / Procurement Section of Birgunj Metropolitan City.
6. In case the last date of obtaining and submission of the EOI documents happens to be a holiday, the next working day will be deemed as the due date but the time will be the same as stipulated.
7. EOI will be assessed based on **Qualification [40%], Experience [40%], and Capacity [20%]** of consulting firm and key personnel. Based on evaluation of EOI, only shortlisted firms will be invited to submit technical and financial proposal (RFP) through a request for proposal.
8. EOIs will be opened in the presence of the applicants or their representatives and relevant authorities. The absence of the applicant's representative will not hinder the opening process.
9. Minimum score to pass the EOI is **60**.
