Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
- 2. The Birgunj Metropolitan City, Integrated Water Supply and Sewerage Management Project, Project Implementation Unit (PIU) (the "Employer"), invites electronic bids from eligible bidders for the construction of **Birgunj Water Supply System** (the "Works").
- 3. Major works under the contract package will be developing infrastructures for water supply in ward no. 1,2,3,4,5,6,7,8,9,10,11,12,13,14,16 and 24 of Birgunj Metropolitan City serving about 170,185 population (2050). The main infrastructures under the Contract are 13 Deep Tube Wells with Aeration Tower / Pressure Filter/Chlorination Units, 5 Overhead Tanks of capacities (300,500,600 and 800 Cum), Transmission Pipeline length of 1.75 Km and Distribution Pipeline length of 321.345 Km with 27,805 households. Other components under the contract package are SCADA, Valve Chambers, various Valves and Fire Hydrants.
- 4. **Open competitive bidding International advertisement** will be conducted in accordance with ADB's Single-Stage: Two-Envelope bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
- 5. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding.
